Update from meeting held on Monday, 14 August Projects Working Group - Alderbury Parish Council

Inputs to the meeting:

The meeting reviewed the following documents/inputs to the meeting:

- 1. Updated Parish Council Reserves schedule as at 31 July 2023 supplied by the Clerk, which showed a revised (lower) amount of £38,816 available to allocate to projects (free reserves) after a correction to the calculation had been made.
- 2. Advice from the clerk that one final payment of CIL money of £24,290 from the Firs Road Development is due for payment to Wiltshire Council in early September and will be transferred to Alderbury PC shortly after it has been received. Added to the free reserves, this would make £63,106 available to allocate to projects (free reserves).
- 3. Options Analysis prepared by Councillor Ridd documenting early ideas on funding needs against the three themes approved by Alderbury PC (July meeting) i.e:
 - I. Community-based hub
 - II. Road safety
 - III. Footpaths/access to canal

and against the assessment criteria also approved by Alderbury PC (July meeting) i.e.:

- I. Timescale
- II. Affordability
- III. Capacity of staff and volunteers to deliver the projects

The Options Analysis also summarised the funds already committed to projects by Alderbury PC for the above themes, which are:

- £6,500 Road Safety (Firs Road LFIG, Second SID)
- £1,500 Improvements to the existing Circular Footpath
- N.B. no funds have presently been committed to the Community Hub

Recommendation:

To request approval from Alderbury PC (September meeting) to develop ideas for projects at the Community Hub, including ascertaining the availability of any grants including for:

The meeting concluded with a walk around the Recreation Field and discussion of present issues and opportunities.

Although the layout of the Recreation Ground has evolved over many years and could benefit from a complete rethink, this is not possible with the free reserves available of £63,106. Consequently, there is a need to be pragmatic and to carefully prioritise the proposed use of free reserves to ensure that a good balance is struck between trying to cover multiple projects whilst also being able to implement meaningful change with each project selected. Also, to ensure that the Community Hub meets present and future needs as well as possible.
