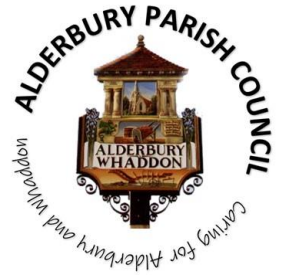

5981. Alderbury Wildlife Project

To consider [the report of Wiltshire Wildlife Trust's Wild Landscapes Team](#), following their survey of the village in May. The report fulfils the initial contract with Wild Landscapes, but should the Council wish to proceed with the projects, these can be arranged on a contract-by-contract basis. The Clerk's suggested [project programme is available to download](#). The Council will note that budget provision and CIL funds can cover the cost of the items set out in the suggested project plan and grants will be sought to cover additional costs involved.

5982. Late Night Bus Service

Whiteparish Parish Council has canvassed local villages about the need to lobby for the introduction of an enhanced night bus service to serve Alderbury, Whiteparish and the Grimsteads. This request follows publication of [Wiltshire Council Briefing Note 21-08](#) explaining how bus services can play an important part in the post COVID-19 economic recovery. A national funding scheme is in place and proposals need to be submitted to Wiltshire Council before Wednesday 14th July 2021. The Council is asked if it wishes to lend its support.

5983. Picnic in the Park

5984. Youth Activities

Councillor Sloan will provide an update on discussions with the Southern Wiltshire Community Engagement Manager about a possible programme of youth activities over the summer.

Councillor Hughes will report on recent flooding events that have been attributed to the clearance of land behind Wagtails in Southampton Road.


