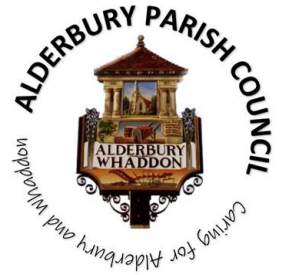

6080. Draft Budget 2022-23

To consider the [Clerk's report and to approve the Council budget 2022/23](#). As agreed at the December meeting, the budget excludes one-off in year project costs as these can be funded from reserves during the year as the need arises. This will help to minimise any increase in precept to assist residents impacted financially by the COVID-19 pandemic. The Council is recommended to agree a precept of £52,889.86 (up from £51,990.00 in 2021-22). This represents an annual increase for Band D properties of £00.46 an uplift of only 0.87% or 3.8 pence per month. The Council is asked to approve the [budget](#), [precept request](#), [annual risk assessment](#) and [asset register](#).
